### **RE: Freedom of Information Request**

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to your request is below.

In the request you asked:

**1a**. Please name the organisation(s) that deliver(s) ASD (autism spectrum disorder) and ADHD (attention deficit hyperactivity disorder) assessments / diagnoses in your ICB area for both adults and CYP (children and young people)?

#### Adults

Nottinghamshire Healthcare NHS Foundation Trust provides our Neurodevelopmental Specialist Service for Autism and ADHD.

#### Children and young people

Assessments are undertaken by the Community Paediatrics teams in our acute hospitals; Doncaster and Bassetlaw NHS Teaching Hospital, Nottingham University Hospitals NHS Trust, and Sherwood Forest Hospitals NHS Trust.

**1b.** When did the contract(s) begin and when is the contract(s) due to end along with any extension clauses included in the contract?

They are rolling contracts reviewed annually.

1c. How is the service contracted - is it Block, Activity-based, or AQP / RTC contracting?

Block contracts.

**1d.** Does the service, sub-contractor or Right to Choose provider provide assessment / diagnosis only or post-diagnosis treatment also, and whether this is through coaching/counselling and/or pharmaceutical treatment?

#### Adults

The Neurodevelopmental Specialist Service currently provides post-diagnostic support including education, signposting and pharmaceutical treatment.

# **Children and Young People**

The Community Paediatrics teams provides post-diagnostic treatment including pharmaceutical treatment as part of a wider neurodevelopmental pathway.

As part of this wider pathway, post-diagnostic support is also provided from our pre/post assessment support services below who provide educational workshops, 1:1 and group support, and parenting programmes.

- 1. Nottingham City Behavioural and Emotional Health team (BEH)
- 2. Nottinghamshire County Neurodevelopmental Behaviour Service (NBS)
- 3. Bassetlaw A Place To Call Our Own (APTCOO)

**1e.** Where post-diagnosis treatment is provided by the service, sub-contractor or Right to Choose provider, please outline what treatment is offered and the spend for 2023-24 and for the last 5 years?

See answer above for post-diagnostic treatment.

# Adults

The contract value for the Neurodevelopmental Specialist Service is £1.2m annually. We are unable to split the cost between assessments and post-diagnostic support as it's a block contract (contract commenced April 2020).

### **Children and Young People**

We are unable to provide a breakdown of spend for the Community Paediatrics teams as they are included in the acute block contracts.

The annual contract values for our pre and post assessment services are:

- 1. Nottingham City Behavioural and Emotional Health team (BEH) £384,540 (contract commenced April 2022)
- Nottinghamshire County Neurodevelopmental Behaviour Service (NBS) £515,256.70 (contract commenced June 2022)
- 3. Bassetlaw A Place To Call Our Own (APTCOO) £113,020 (contract commenced April 2023)

Nottingham and Nottinghamshire ICB do not hold a breakdown of spend by pre and post diagnostic support as they are block contracts.

# Adults

# Neurodevelopmental Specialist Service (NeSS)

• Waiting list initiative in place to increase capacity for assessments and reduce the waiting list backlog.

- A weekly NeSS clinic is now taking place at each of the University GP practices to provide preassessment screening and support.
- Undertaking forecasting for future demand and capacity to inform workforce plan and future service planning with commissioners.
- Qb1 testing for ADHD assessments commenced in July 23 as part of a pilot to support assessments for those with more complex presentations.
- Waiting times for Non-Medical Prescribers have reduced from 8 months to 4 months through process efficiency measures
- Referrals screening process has changed increasing staffing by 25%, resulted in 50% more referrals being screened each month, reducing backlog and bringing referrals up to date

# Children and Young People

### Neurodevelopmental Behaviour Service (NBS) /Behavioural Emotional Health Team (BEH)

- Reviewing the service to reduce the inherited waiting lists and lengthy waiting times focus on referrals process, triage assessment and parenting support. Improvements have already been seen within waiting times for both services.
- Additional non-recurrent funding has been confirmed for this year to provide an additional Specialist Practitioner in each service for 12 months to increase capacity.

#### **Community Paediatrics**

- Additional investment provided to increase capacity and support the waiting list initiatives with NBS and BEH due to the interdependencies and knock on effect in the assessment pathway.
- Funding for Consultant Psychologist and Speech and Language posts has been agreed to support the autism assessment pathway.

The LD/A Transformation & Commissioning Team are working with partners to review the CYP and Adult Autism and ADHD pathways in line with national guidance including the recently published NHSE all age autism framework and operational guidance for commissioners and providers. This will inform future commissioning intentions to deliver a sustainable, timely assessment pathway that meets the needs of our population. A CYP neurodevelopmental website is also being developed which will act as a single point of information for autism and ADHD in Nottingham and Nottinghamshire. If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
