RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to your request is below.

In the request you asked:

1. Do you have a children's palliative care service specification? (Yes/No). If so, please attach a copy to your response to this request.

Yes, the ICB has a children's palliative care service specification for the following;

- as part of the children's community nursing team element of the attached specification.
- for the ICB's commissioning of routine care delivered by a children's hospice.
- for support services.

Please see attached specifications.

2. Has your ICB completed an Ambitions for Palliative and End of Life Care self-assessment? (Yes/No). If yes, please attach your completed self-assessment to your response to this FOI request.

The ICB do not hold this information, the Ambitions for Palliative and End of Life Care self-assessment for Nottingham and Nottinghamshire ICS is currently in the process of being completed.

3. Do you have a children's palliative care service specification which states that infants, children and young people with a life-limiting condition and their parents or carers should have opportunities to be involved in developing an advance care plan? (Yes/No)

No

4. Do you have a children's palliative care service specification which states that infants, children and young people with a life-limiting condition should have a named medical specialist who leads and coordinates their care? (Yes/No)

No, this service is commissioned by NHS England.

5. Do you have a children's palliative care service specification which states that infants, children and young people with a life-limiting condition, their parents or carers and their siblings should be given information about emotional and psychological support, including how to access it? (Yes/No)

Yes. Please see attached specifications which all include provision of emotional and psychological support. However, it is not stated within these specifications as to how the access is provided.

6. Do you have a children's palliative care service specification which states that infants, children and young people with a life-limiting condition should be cared for by a multidisciplinary team that includes members of the specialist paediatric palliative care team^[1]? (Yes/No)

No, however multidisciplinary team care is included in the specifications but does not specifically state members of the specialist paediatric palliative care team.

7. Do you have a children's palliative care service specification which states that siblings and parents or carers of infants, children and young people approaching the end of life should be offered support for grief and loss when their child is nearing the end of their life and after their death? (Yes/No)

Yes

8. Do you have a children's palliative care service specification which states that infants, children and young people approaching the end of life and being cared for at home should have 24-hour access to both children's nursing care^[2] and advice from a consultant in paediatric palliative care? (Yes/No)

Yes, for children's community nursing and for 24/7 medical advice under the hospice service specification from the hospice medical teams.

9. Do you have a children's palliative care service specification which states that infants, children and young people with a life-limiting condition and their families should have access regular short breaks for respite? (Yes/No)

Yes, for hospice care the specification includes 10 nights of specialist residential palliative respite care per child over a year.

No, not within the children's community nursing specification however it does state that the service provides training to enable short breaks provision. Please contact Nottingham City Council and Nottinghamshire County Council regarding access to regular short breaks. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
