RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to your request is below.

In the request you asked:

Was a lump sum paid by the ICB to Trent PTS to disseminate to their staff for the year 2022/23 when this lump sum payment was agreed at government level earlier this year. Or, was this paid to Vita Health Group who took over the Nottingham and Nottinghamshire contract as Nottingham and Nottinghamshire Talking Therapies and who TUPEd over the employees from Trent PTS as part of this contract.

Nottingham and Nottinghamshire ICB can confirm that no lump sum was paid to Trent PTS or Vita Health Group.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
