Re: Freedom of Information Request

Thank you for your request for information, received on 19 May 2025, regarding bariatric care. We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

Under the FOIA, public authorities like ours are required to respond to requests for information within 20 working days. In response to your request, I can confirm that we do not hold the information requested.

Details of your request:

We would like to raise a FOI request as below:

- Total number of people in Notts ICB hospitals over 200kg.
- Breakdown of numbers in each ICB location, (e.g. Queens, City, Kingsmill).
- Number of care home discharges for hospital patients over 200kg.
- The best contact at Nottingham ICB to discuss care homes facilities for people over 200kg.
- Average cost of hospital stay per day or week for a patient over 200kg.
- Average Package of care for anyone over 200kg.

Our response to your request:

The ICB does not hold this information. NHS Nottingham and Nottinghamshire ICB is a commissioner of health services; it does not provide services and, as such, does not have/treat patients. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
