Re: Freedom of Information Request

Thank you for your request for information, received on 9 July 2025, regarding Neighbourhood Teams. We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

Under the FOIA, public authorities like ours are required to respond to requests for information within 20 working days. In response to your request, I can confirm that we do not hold the information requested.

Details of your request:

With regards to the recently published NHS 10 Year Plan and the creation of Neighbourhood Teams to deliver prevention and care in the community, I would like to know the following information please:

- How many Neighbourhood teams are being created within your jurisdiction/area?
- What will each team be called?
- Who is running the new Neighbourhood teams?
- Which GP Network will hold the contract?
- Who is the Chairperson of the relevant network running the Neighbourhood team?

Our response to your request:

The ICB does not hold the information requested and is currently working with Partners to design local arrangements within 2025/26.

Once agreed, this information will be published at a future date through our Board papers - <u>Our Board - NHS Nottingham and Nottinghamshire ICB</u>.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) has an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
