Re: Freedom of Information Request

Thank you for your request for information, received on 11 July 2025, regarding blood glucose. We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

Under the FOIA, public authorities like ours are required to respond to requests for information within 20 working days. In response to your request, I can confirm that we do hold the information requested.

Please find below our response to your request:

I would please like to request the following information in line with The Freedom of Information Act 2000 regarding the guidance / formulary in place relating to the commissioning recommendations of blood glucose meters, test strips and lancets within the ICB.

1. Do you have a local formulary which you follow alongside the NHS England commissioning recommendations?

Yes.

2. If so, when will the local formulary be reviewed?

For the Nottinghamshire area, August 2025 will be the planned date to next review our Blood Glucose/strips formulary.

For the Bassetlaw area, this date will be March 2029.
