Re: Freedom of Information Request

Thank you for your request for information, received on 22 July 2025, regarding joint funded packages of care. We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

Under the FOIA, public authorities like ours are required to respond to requests for information within 20 working days. In response to your request, I can confirm that we do hold the information requested.

Details of your request:

I wish to make a FOI request for the following information :

1. The number of reviews of joint funded packages of care for persons residing in Notts ICB area care homes in 2024 and 2025, showing the relevant social care service area providing the care part of the joint funding.
2. The number of the reviews above which have a) confirmed and b) withdrawn the health care element of funding at 2024 and 2025 review, showing, in each case, the relevant social care service area providing the care part of the funding.

Our response to your request:

In 2024 there were 258 reviews completed for Joint Funded patients in care homes.

Of these 258, the Local Authority responsibility is split as follows:

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
