**Re: Freedom of Information Request** 

Thank you for your request for information, received on 24 July 2025, regarding adult nursing care placements and discharge teams. We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

Under the FOIA, public authorities like ours are required to respond to requests for information within 20 working days. In response to your request, I can confirm that we partially hold the information requested.

## Please find below our response to your request:

I would be most grateful if you would provide me, under the Freedom of Information Act, the details below.

1. An organisational structure chart of the ICB.

  - Referrals Team

Nottingham and Nottinghamshire ICB are a party to the contract held by our Local Authority for placements in Nursing and Residential homes.

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
