**Re: Freedom of Information Request** 

Thank you for your request for information, received on 30 July 2025, regarding information on mental health commissioner and supported accommodation in Nottingham. We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

Under the FOIA, public authorities like ours are required to respond to requests for information within 20 working days. In response to your request, I can confirm that we do not hold the information requested.

## **Details of your request:**

- 1. Who is currently the Mental Health Commissioner for Nottingham?
- 2. Which department or contact person I would need to speak with regarding the application or approval process for running a supported accommodation service in the area?
- 3. Whether there is any current data or insight into the demand for adult supported living services, particularly those specialising in forensic mental health?

## Our response to your request:

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
