The ICB does not hold this information.



5. What proportion of capital funding is directed to mental health estates each year?

Please refer to Table 2 below.

Table 2 below, shows the planned spend (£m's) of the system capital allocation for the last five years, across the three system providers i.e. Nottingham University Hospitals NHS Foundation Trust (NUH), Sherwood Forest Hospitals NHS Foundation Trust (SFH) and Nottinghamshire Healthcare Trust (NHT), in line with the final Month 12 formal reporting to NHS England.

The percentage (%) split at the bottom of the table, across acute and mental health, has been done on the basis that NUH and SFH are classed as acute and NHT is classed as mental health.
