**Re: Freedom of Information Request**

Thank you for your request for information, received on 21 January 2025, regarding current and future plans for IT service delivery models. We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

Under the FOIA, public authorities like ours are required to respond to requests for information within 20 working days. In response to your request, I can confirm that we partially hold the information requested.

Please find below our response to your request:

- 1) Current IT Service Model – Is your IT delivery primarily in-house, outsourced, or a hybrid approach, and if not delivered in-house, who provides this service?

The Integrated Care Board's (ICB) IT delivery is primarily outsourced to Nottinghamshire Health Informatics Service (NHIS) via a shared service style model.

- 2) Major IT Contracts – Key details of significant IT service contracts (including scope, value, end date and any options for extension or renegotiation).

In order for the ICB to process your request successfully, please can you clarify your request and confirm what recorded information you require in relation to specific IT service contracts.

- 3) Future IT Plans – Any strategic plans or considerations for changing IT delivery models (e.g., outsourcing, in-sourcing, multi-sourcing).

The ICB has no plans for changing IT delivery Models.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) has an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
