Re: Freedom of Information Request

Thank you for your request for information, received on 3 February 2025, regarding pressure care guidance and procedure. We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

Under the FOIA, public authorities like ours are required to respond to requests for information within 20 working days. In response to your request, I can confirm that we do hold the information requested.

Please find below our response to your request:

 Please provide any ICB guidance on pressure care (for the care and prevention of pressure sores, pressure ulcers, or bed sores) issued to administrators and/or hospital staff in the last 24 months.

The ICB has not provided any guidance on pressure care to administrators or hospital staff in the last 24 months.

Guidance on pressure care comes from the national team – NHSE/NICE so you may wish to make a request to NHSE/NICE:

One case was relating to a patient care concern received from a hospital PALS to the ICB's Care Homes Quality Team.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) has an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
