Re: Freedom of Information Request

Thank you for your request for information, received on 21 February 2025, regarding Community Diagnostic Centres. We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

Under the FOIA, public authorities like ours are required to respond to requests for information within 20 working days. In response to your request, I can confirm that we do hold the information requested.

Please find below our response to your request:

A. Please confirm the number of operational Community Diagnostic Centre (CDC)'s under the ICB. And of this number how many are:

1. Standard
2. Large
3. Hub and spoke

There will be two CDCs within the ICB footprint, but at the time of writing (March 2025), none are currently operational.

B. Please list the locations of the sites along with their designation (Standard, Large or Hub and Spoke)

Nottingham CDC (when the Nottingham permanent CDC is operational, it is forecast to deliver the following activity):

1. Imaging

- MRI - 7,400
- CT - 9,200
- X-ray - 21,200
- Non-obstetric ultrasound - 7,600

2. Pathology

- Phlebotomy - 29,000

3. Physiological science

- Echo - 5,000
- ECG - 11,900
- Ambulatory ECG - 2,900
- Respiratory physiology - 17,300

D. Large model – which services are being provided and annual activity levels e.g. pathology – phlebotomy x amount of tests.

Mansfield CDC (when the Mansfield permanent CDC is operational, it is forecast to deliver the following activity):

1. Imaging

- MRI 7,776
- CT 8,736
- X-ray 8,160
- Non-obstetric 9,100

2. Pathology

- Phlebotomy 33,824
- Point of care testing 3,448

3. Physiological science

- Echo 4,688
- ECG 1,295
- Ambulatory ECG 1,256
- Respiratory physiology 2,092

4. Endoscopy

- Endoscopy 11,285
- Hysteroscopy 728

E. Hub and Spoke model – which services are being provided and annual activity levels e.g. pathology – phlebotomy x amount of tests.

NHS Nottingham and Nottinghamshire ICB is not planning to implement a hub and spoke model.

F. Is audiology or hearing services including wax removal offered at any of the sites listed above? Please list the locations where it is being offered.

Nottingham CDC currently has no plans to provide audiology, hearing services, wax removal services.

Mansfield CDC currently has no plans to deliver audiology.
