Re: Freedom of Information Request

Thank you for your request for information, received on 12 March 2025, regarding numbers of children being prescribed GLP-1 drugs for weight reduction (so-called "skinny jabs"). We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

Under the FOIA, public authorities like ours are required to respond to requests for information within 20 working days. In response to your request, I can confirm that we do not hold the information requested.

Details of your request:

Mail journalist's urgent enquiry re GLP-1 prescribing to children (numbers of children being prescribed GLP-1 drugs for weight reduction (so-called "skinny jabs").

I note from your trust's online information that you have a protocol for prescribing these drugs to children above the age of 12. (Link here: [Nottinghamshire Area Prescribing Committee Formulary](#))

Could you tell me please:

To how many children between the ages of 12 and 18 have you prescribed these drugs?

And when did you first begin prescribing them?

Our response to your request:

The ICB does not hold this information.

If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
