**Re: Freedom of Information Request** 

Thank you for your request for information, received on 18 March 2025, regarding data on female and male patients with acquired brain injury. We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

Under the FOIA, public authorities like ours are required to respond to requests for information within 20 working days. In response to your request, I can confirm that we do not hold the information requested.

## **Details of your request:**

Could you kindly provide the following information for the period from January 2024 to December 2024 (inclusive):

- 1. The total number of female patients with ABI on your caseload during this time frame.
- 2. The total number of male patients with ABI treated during the same period.

## Our response to your request:

The ICB does not hold this information. NHS Nottingham and Nottinghamshire ICB is a commissioner of health services; it does not provide services and, as such, does not have patients. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
