Re: Freedom of Information Request

Thank you for your request for information, received on 11 April 2025, regarding NHS Lung Cancer Screening (LCS) programme (previously known as the Targeted Lung Health Check). We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

Under the FOIA, public authorities like ours are required to respond to requests for information within 20 working days. In response to your request, I can confirm that we do hold the information requested.

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
