**Re: Freedom of Information Request** 

Thank you for your request for information, received on 28 October 2025, regarding employee ages. We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

Under the FOIA, public authorities like ours are required to respond to requests for information within 20 working days. In response to your request, I can confirm that we do hold the information requested.

## **Details of your request:**

I'm looking to find out how many people your integrated care board employs in all capacities who are aged over 70, over 80 and over 90 years old. Please can I have the figures for each of these age bands?

Please do not include anyone who is employed by local trusts, I will ask for this information from them myself.

And can you please tell me how many people the ICB employs overall? (Of all ages and in all capacities).

If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
