Re: Freedom of Information Request

Thank you for your request for information, received on 30 October 2025, regarding Information Technology/Artificial Intelligence/Devices/Procurement. We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

 - The ICB uses co-pilot, at zero cost, as this is part of a wider NHS England pilot. Future plans beyond 2025/26 are not yet confirmed.
