Re: Freedom of Information Request

Thank you for your request for information, received on 9 February 2026, regarding all Local Enhanced Services (LES) and Locally Commissioned Services (LCS). We have processed your request in accordance with the Freedom of Information Act 2000 (FOIA).

Under the FOIA, public authorities like ours are required to respond to requests for information within 20 working days. In response to your request, I can confirm that we do hold the information requested.

Please find below our response to your request:

I am requesting information about Local Enhanced Services (LES) and Locally Commissioned Services (LCS) commissioned by NHS Nottingham and Nottinghamshire ICB for the current financial year (2025/26). Please provide the following information:

1. SERVICE INVENTORY

- a) A complete list of all Local Enhanced Services (LES) and Locally Commissioned Services (LCS) currently commissioned by your ICB.
- b) For each service, please provide:
 - Official service name
 - Whether delivered at practice level or PCN level
 - Start date of current contract
 - End date of current contract (if applicable).

2. FINANCIAL INFORMATION

- a) Total budget allocated to LES/LCS for 2025/26
- b) Payment structure for each service (e.g., per patient, per activity, annual fee)
- c) Payment rates for each service.

3. PARTICIPATION DATA

a) Number of GP practices eligible to participate in each LES/LCS

All practices are eligible to participate.

b) Number of PCNs participating in each LES/LCS (where applicable)

All LES's are only available at Practice level.

4. PUBLIC INFORMATION

a) Website links or public documents where patients can find information about LES/LCS available in their area.

Specifications are available to practices only via TeamNet, which is not available to the public.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) has an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
