Re: Freedom of Information Request

Thank you for your request for information, received on 26 February 2026, regarding adult cardiometabolic services. Your request has been processed in accordance with the Freedom of Information Act 2000. Under the Act, public authorities are required to respond within 20 working days. We can confirm that the ICB partially holds the information requested.

Where information is not held in the format requested, this is because adult cardiometabolic services are commissioned as part of broader acute contracts and are not always separately identified within contract documentation.

Please find below our response to your request:

1. Please provide a list of all providers the ICB holds contracts with for adult cardiometabolic services (covering any form of cardiometabolic, cardiology or cardiovascular services).
 - Please include both statutory NHS and Independent Sector providers;
 - Please include any broader services that include a cardiometabolic element (for example a broader cardiovascular service, or a community service that covers cardiology care.)

The ICB commissions adult cardiometabolic services as part of wider acute service contracts. The following providers deliver adult cardiometabolic services under those arrangements:

- a) Circle Health Group - The Park Hospital (Independent Sector provider)
- b) Ramsay Health Care - Woodthorpe Hospital (Independent Sector provider)
- c) Nottingham University of Hospitals NHS Trust
- d) Sherwood Forest Hospitals NHS Foundation Trust
- e) Doncaster and Bassetlaw Teaching Hospitals NHS Foundation Trust.

No additional standalone contracts for cardiometabolic services are held.

Nottingham and Nottinghamshire ICB is an Associate to the following acute service contracts:

- a) Chesterfield Royal Hospital (CRH) and
- b) University Hospitals Derby & Burton (UHDB).

Please note that Derby and Derbyshire ICB is the Contract Lead for both CRH and UHDB.

2. For each contracted provider listed in the answer to #1, please provide the following schedules as included in the contract the ICB holds:

- Schedule 2A or equivalent: Service Specification that describes the service (whether standalone or integrated in a broader Service Specification);

The ICB does not hold a standalone Service Specification specific to cardiometabolic. Cardiometabolic services are included within broader, integrated service specifications contained within the NHS Standard Contract for acute services. These specifications are not disaggregated by specialty.

- Schedule 3A, 3B or 3C or equivalents: Describing national currencies and any local prices that apply to the services.

The ICB does not hold separate pricing schedules specific to cardiometabolic services. All relevant activity is reimbursed in accordance with the NHS National Tariff Payment System. No local pricing arrangements specific to cardiometabolic are in place.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) has an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
